- ✓2 Populus alba is listed as only poplar species. Consider all Populus species as labelled.

- ✓3 Correspondence from PMRA clearly states: "New and Established Plantings of *Populus* species (Poplars and Aspens) and Their Hvbrids (including Short Rotation Intensive Culture SRIC"). Thus it includes planting stock production of poplars (field-grown), either stoolbeds or bareroot beds.
- ✓4 Special caution is needed for all operators; see website. Label allows shelterbelt use and inter-row directed chemical weeding of (vegetable), field and established nursery crops. It does not specify crops. Note the health warnings on the label and the need for full PPE see: www.syngenta.com/pqmedguide.
- ✓5 Includes nurseries for rooted cuttings (poplar and aspen).
- ✓6 Labelled for poplar plantings, which logically should include shelterbelt poplars.
- √7 Second-year or older stoolbed.
- **X-1** Use after crop established for 6 months; bare soil required.
- **X-2** Post-Emergent in a tank mix with glyphosate.
- X-3 Early Post-Emergent.
- Note 1 This product is on the way out Still OK for use, pending re-evaluation; email correspondence 14 May 2012.
- **Note 2** Venture L still sold in eastern Canada and can be obtained through national distributors note from Syngenta via Jim Chaput on 4 January 2011.
